A MESSAGE FROM THE CEO

Dear Friends,

As fall approaches, we anticipate cooler weather, changing colors, and, except for Mets fans like me, the World Series. One of the first events to mark the change of the season is the start of school.

As I write this in August, retailers are promoting backpacks, supplies, and clothes to ready children for the new school year. But not all parents are backto-school shopping. For many moms and dads, the basic needs of a roof overhead, food on the table, and a way to stay together take precedence. Despite a growing economy, wages have not kept pace with housing and living costs, and family homelessness has not abated.

Ending this American tragedy is not the province of any one sector. With Family Promise, we rally community stakeholders—congregations, volunteers, civic groups, corporations—as partners who shelter families, provide stabilization, and even prevent homelessness altogether to undergird long-term success. But our government's approach plays a critical role.

In this issue you will read about Family
Promise graduate Kat Lilley who recently
testified to Congress about critical
legislation, the Homeless Children and
Youth Act. The HCYA can ensure that
vulnerable families and children get the

# Making the Voices of Homelessness Heard

Having overcome great obstacles, Family Promise graduates are often inspired to use their experiences to help others. This summer, several graduates ensured the voices of families battling homelessness are not forgotten.

## Protecting the Most Vulnerable

In June, Kat Lilley, now a Family Promise
Guest Advisory Council member and
Deputy Director of Family Promise of
Colorado Springs, spoke before the
House of Representatives Committee
on Financial Services to advocate for
the Homeless Children and Youth
Act (HCYA). Lilley shared her story to
bring attention to the vulnerability of
struggling families who aren't considered
homeless as defined by the Department
of Housing and Urban Development (HUD).

She also described a family who lived in squalor in an unsafe, low-budget motel and risked eviction because neighbors complained about their baby's crying.

Despite extreme poverty, the only assistance they were eligible for under HUD's criteria was rapid rehousing since they already had some form of shelter.

As Lilley explained, "This family wasn't suitable for rehousing without addressing the vulnerability that made them homeless to begin with. Addressing only the direst family situations excludes some of society's most vulnerable. We're asking you to include individuals currently victimized because of their situations."



The HCYA passed committee and goes to a House vote this fall.

#### The Path to Affordable Housing

Two graduates of Family Promise-Union
County were invited to speak at a
congressional reception in Washington,
D.C., in July. The event, organized by Family
Promise partner Monarch Housing, a New
Jersey-based housing advocacy group,
sent more than 350 supporters to the
nation's capital to engage with New Jersey's
congressional representatives about
affordable housing.

Single mom Nichole Allen was two classes shy of her college degree when she came to

opportunities they need to escape homelessness. Kat's words helped the HCYA pass the House Financial Services Committee; it goes to a full House vote later this fall. If the law had been in place when she faced a dire family crisis several years ago, Kat and her children never would have experienced homelessness.

You'll also hear about two Family Promise graduates who spoke about affordable housing at a congressional reception. More and more often, after returning from Family Promise to a stable life, families want to make the voices of society's most vulnerable heard.

Matching this effort to shape policy, Family Promise, in conjunction with the National Association of Realtors, has created a curriculum to teach Family Promise clients about tenancy. Keys to Good Tenancy is a significant joint effort, bringing together two organizations that share a similar goal: getting families into homes. As important as advocating on the issue of homelessness is, engaging the business community is just as vital. The resources to solve family homelessness exist in every community.

We look forward to seeing more families gaining housing as a direct result of both our work on policy and our broadening of the response to homelessness. For too many children, the afternoon bell at school signals uncertainty, instability, and insecurity. Working together, we can make sure that no child has to wonder where he or she will sleep tonight.

introduced her to the national organization headquartered in her hometown. Impressed by the nonprofit and its model for putting families on the path to independence, Family Promise has been an important part of her life ever since.

"I first volunteered by preparing and serving meals for families." she recalls.

Susan had always viewed the lack of affordable housing in this country as a major problem and welcomed the handson opportunity to address the crisis. She witnessed firsthand the transformative effect Family Promise had on the lives of struggling families.

## Family Promise Makes Good Neighbors

In an effort to engage all sectors of the community in the solution to family homelessness, Family Promise is excited to launch Keys to Good Tenancy, a program that matches real estate professionals with families seeking housing. Working with the National Association of Realtors (NAR), Family Promise developed the program to address all aspects of tenancy, from understanding a lease, to home maintenance, to being a good neighbor.

As Family Promise CEO Claas Ehlers notes, "It's a perfect marriage. Family Promise and NAR share the same mission: putting people in homes!"

Working with Affiliates, realtors are trained to teach the course. Graduates receive a certificate of completion and become more desirable tenants. Initial feedback has been positive, and other groups have expressed interest, including landlord associations that recognize the value of educating tenants.

NAR crafted the curriculum with input from Affiliate Executive Directors and members of the Guest Advisory Council (GAC), a body

of Family Promise graduates, who ensured the materials targeted the needs of families battling homelessness.

GAC member Tammi Hart sees great value in the course.

"It's a wealth of knowledge I wish I'd had years ago and can still use today," she says.

For realtors, the program presents an unparalleled opportunity to have a direct impact on children and families. Ryan Desch and Rob Hulse of the Lawrence

(KS) Board of Realtors were instrumental in launching the program in their community.

"Families learn the essentials of tenancy and how to advocate for themselves," Hulse explains.

For Affiliates, the program will deepen relationships with housing providers, creating more opportunities for families to find housing. For landlords, better educated tenants mean fewer challenges. Family

Promise and NAR hope the curriculum will gain wider usage among all organizations that serve families facing homelessness.



Dana Ortiz, Executive Director of Family Promise of Lawrence, KS, says things are already moving in that direction in her community.

"We've developed a valuable relationship with the real estate profession and started an important conversation in the community about homelessness," she says. "This can only benefit Family Promise and the families we serve."
